



MEMORANDUM OF UNDERSTANDING BETWEEN
KYUNG DONG UNIVERISTY AND AUTONOMOUS UNIVERSTY OF NAYARIT

Kyungdong University (KDU) and Autonomous University of Nayarit (UAN), wishing to enhance relations between the two universities and to develop academic exchange in the areas of education, research, and other activities, agree to cooperate and work together towards the internationalization of higher education.

The areas of cooperation will include any program offered at either university that is felt to be desirable and feasible for the development and strengthening of cooperative relationships between the two institutions.

Any specific program outline here-in-below shall be subject to mutual consent, and approval of each university by the appropriate responsible officers of both parties. Each area of cooperation shall require specific follow-up agreement(s), or addendum prior to the initiation of any particular program or activity. Such program may include:

- A. Exchange of Students including but not limited to the ONE-Semester or One-Year Undergraduate Student Exchange Program.
- B. Exchange of Faculty Members
- C. Joint Research Activities.

This agreement shall come into effect from the date of its signing by both parties, and be considered automatically renewed on an annual basis thereafter, unless terminated or replaced with another agreement. This agreement may be terminated by either party with a written advance notice of at least ten months.

This agreement is written in English.
