**MEMORANDUM OF UNDERSTANDING**  
**Between**  
**NAYARIT AUTONOMOUS UNIVERSITY, MEXICO**  
**and**  
**HANKUK UNIVERSITY OF FOREIGN STUDIES, KOREA**

For the purpose of furthering cooperation through educational and academic exchanges, Nayarit Autonomous University and Hankuk University of Foreign Studies hereby agree to foster the establishment of a mutually beneficial relationship for their institutions.


1. Educational and academic exchanges are considered here to include but not be limited to:
  - A. Development of mutually beneficial academic programs and courses;
  - B. Exchange of academic staff for purposes of teaching and research;
  - C. Reciprocal assistance for visiting academic staff and students;
  - D. Coordination of such activities as joint research, lectures and training;
  - E. Exchange of documentation and research materials in fields of mutual interest provided that, to the best knowledge of the respective institutions, there is no prohibition at law or otherwise against the exchange; and
  - F. Exchange of students for study and research.
2. Details of the implementation of any particular student exchange or faculty-related activities resulting from this Memorandum of Understanding shall be negotiated between the two institutions. As such specific cases may arise, and shall be outlined in writing as Supplementary Agreements. Such Agreements are always subject to availability of sufficient funds to the respective institutions.
3. This Memorandum of Understanding shall enter into force upon signature by both parties and remain in force for an initial period of five years. At the end of the initial five year period, this Memorandum of Understanding shall be automatically renewed for successive five year periods unless terminated by either party with six months written notice.
4. Any amendment or termination shall not have an effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.
5. This MOU is subject to, and shall be interpreted in accordance with the laws of South Korea if a


dispute arises in South Korea, or the laws of Mexico if a dispute arises in Mexico.
